At the completion of this course in the clinical setting, the student will be able to:

- 1. Demonstrate safe, competent nursing care utilizing the nursing process and Maslow's Hierarchy of Needs theory.
- 2. Apply behavior management principles and techniques.
- 3. Demonstrate ability to plan, implement and evaluate individual behavioral care planning appropriate to the residents need and developmental level.
- 4. Demonstrate knowledge of and the ability to administer, evaluate and document medications.
- 5. Perform in a manner that adheres to all professional, legal and ethical standards and laws.
- 6. Demonstrate knowledge of community living, sheltered workshops and vocational day programs.
- 7. Implement nursing care appropriate to specific syndromes, seizure disorders, cerebral palsy and other disabling conditions.
- 8. Implements nursing care appropriate for communicable diseases and other medical conditions.
- 9. Completes a Functional Skills Assessment on assigned resident.

Topics and Scope:

- 1. Safe, competent nursing care utilizing the nursing process and Maslow's Hierarchy of Needs theory.
- 2. Behavior management principles and techniques.
- 3. Behavioral care planning appropriate to residents need and developmental level.

- 4. Psychopharmacology; administration and documentation.
- 5. Professional, legal and ethical standards, laws.
- 6. Community living, sheltered workshops and vocational day programs.
- 7. Nursing care of residents with specific syndromes, seizure disorders, cerebral palsy and other disabling disorders.
- 8. Nursing care of residents with communicable diseases and other medical conditions.
- 9. Assessment of functional skills.

Assignment:

- 1. Reading assignments in preparation for each clinical day from required texts and clients records, 10-20 pages per week.
- 2. Complete an Intensive Learning Project as assigned.
- 3. Complete a Functional Skills Assessment utilizing correct format and present to peers.
- 4. Pass an oral quiz, administer, evaluate results of and document medications for a selected group of residents.
- 5. Perform and present basic assessments for select residents.
- 6. Document resident behavior on a daily basis using the SOAP format.
- 7. Perform nursing care appropriate to the clients need and developmental level.
- 8. Actively participate in clinical conference.

Methods of Evaluation/Basis of Grade:

Writing: Assessment tools that demonstrate writing skills and/or require students to select, organize and explain ideas in writing.

Written homework, Term papers, Documentation utilizing SOAP form

Problem Solving: Assessment tools, other than exams, that demonstrate competence in computational or non-computational problem solving skills.

Homework problems, Field work, Intensive Learning Project, Functional Assessment

Skill Demonstrations: All skill-based and physical demonstrations used for assessment purposes including skill performance exams.

Class performances, Field work, Performance exams

Exams: All forms of formal testing, other than skill performance exams.
