### **COURSE CONTENT**

#### **Student Learning Outcomes:**

At the conclusion of this course, the student should be able to:

1. Apply evidence-based psychiatric theoretical concepts to clinical practice.
2. Use nursing process to provide safe nursing care for psychiatric patients.
3. Collaborate with patients, families, and members of the interdisciplinary care team to prioritize psychiatric patient care needs and promote optimal wellness.

#### **Objectives:**

Upon completion of this course, the student will:

1. Discuss the theoretical basis for psychiatric nursing practice.
2. Compare and contrast the neurologic function of persons with and without psychiatric illnesses.
3. Describe behavioral patterns associated with psychiatric illnesses and their interference with psychiatric patients' ability to meet self-care needs.
4. Discuss pharmacologic and behavioral interventions to assist psychiatric patients to meet their self-care needs.
5. Compare and contrast pathophysiology, clinical presentation and therapeutic modalities of psychiatric illnesses occurring in different phases of the lifespan.
6. Discuss how psychiatric illness affects clients' interactions with the criminal justice system.
7. Make focused assessments of clients with acutely and chronic illnesses.
8. Use problem solving and facilitative communication skills to conduct interviews and teaching

sessions with acutely and chronically ill patients.

9. Describe community resources for the treatment of chronic illness and maintenance of mental health.

10. Administer psychiatric drugs safely and appropriately.

11. Use nursing process to devise care plans and to deliver care for patients with chronic illnesses.

12. Evaluate strategies for promoting optimal wellness and managing chronic illnesses in the outpatient setting.

### **Topics and Scope:**

1. Psychiatric theories.

2. Neurologic function and dysfunction associated with psychiatric illness.

3. Behavior patterns and therapeutic interventions for psychiatric illness:

a. Thought disorders

b. Mood disorders

c. Anxiety and somatoform disorders

d. Self-destructive and suicidal patients

e. Abusive and violent patients

f. Substance abuse and dependence

g. Eating disorders

h. Personality disorders

4. Psychiatric disorders of childhood and adolescence.

5. Psychiatric disorders of the elderly.

6. Forensic psychiatric nursing.

7. Problem solving and communication with psychiatric patients.

8. Community-based care of chronically ill patients.

9. Psychiatric medications.

10. Psychiatric assessment.

11. Psychiatric care planning.

### **Assignment:**

1. Reading assignments per week (50-100 pages).

2. Present patient situations for discussion in clinical conferences (6-7).

3. Analysis of patient care situations. In group setting, approximately (12-15 per course).

4. (3-5) Clinical papers, (4-5) pages each.

5. One psychiatric care plan with 3 nursing diagnoses.

6. Care of psychiatric and chronic-care patients in inpatient and community settings (minimum 120 hours total).

7. Exams (4).

### **Methods of Evaluation/Basis of Grade:**
