### **Objectives:**

3. Demonstrate basic knowledge of professionalism, current telephone techniques, technology, and procedures.
4. Describe public safety radio procedures, including critical incident .

6. Identify the significance of gang related issues, domestic violence, cultural diversity, hate crimes, child, elder and dependent adult abuse, and sexual harrassment.
7. Employ a practical application activity based upon actual events.
8. Utilize techniques for wellness management.
