6. proper arrest and detention procedures, adults and juveniles.

 3. Fire cause (Natural-Accidental).
 4. Determining point of origin, char, heat, and smoke patterns.
 5. Identification, collection, and preservation of evidence.
 6. Firesetters, motives and methods.
 7. Cooperative investigating agencies and sources of information.
 8. Field notetaking, fire scene recording.
 9. Interviewing witnesses and suspects.
 10. Arrest and detention procedures.
 11. Reports and records.
 12. Courtroom demeanor and testimony.
