

**Child 90.1: *Child, Family, Community Interrelationships* Course Description:** This course explores the diversity of family systems, sociocultural factors affecting the child's development and the socializing influences of community. This course meets the educational requirements for the Child Development Permit issued by the State of California Commission on Teacher Credentialing and child care licensing requirements. (**Recommended Preparation:** Eligibility for English 100 or ESL 100)

**Student Learning Outcomes for Child 90.1: Students will be able to**

1. Analyze theories of socialization that address the interrelationships of the child, family, peers and community.
2. Critically assess how educational, political, cultural and socioeconomic factors and changes directly impact the lives of children and families.
3. Describe strategies that support and empower families through respectful, reciprocal relationships and encourage the involvement of all families in their children's development and learning.
4. Analyze their personal values, goals and sense of self as related to family history and life experiences, and assess how this impacts their role with children and families.
5. Critically assess community support services and agencies that are available to community and families.

**Required materials:** Text: The Child in the Family and the Community, 7<sup>th</sup> edition by Janet Gonzalez-Mena. Also you will be required to purchase an instructor prepared e-text or reader. Information regarding the purchase of required materials will be given in class.

**Course Procedures and Guidelines:**

### **Classroom Conduct:**

All students are expected to follow the standards of conduct of Santa Rosa Junior College. Please remember that we may not all agree on some issues that we discuss in class. **Grades:** All work will be assigned a point value and graded accordingly. At the end of the semester, points will be totaled and grades based on the following percentages:

- A- 90-100% of points possible
- B- 80-89% of points possible
- C- 70-79% of points possible
- D- 60-69% of points possible

Grades will be based on the following:

- attend class regularly
- complete all required assignments
- read the assigned chapters in the text by the date given
- participate in class discussions
- complete all tests and the final during the semester
- complete any miscellaneous assignments given in class

### **Assignments:**

1. Attendance - It will be taken at the beginning of each class. If you arrive late, it is your responsibility to let the instructor know at the end of class. If you miss more than one class, your grade could be affected. **There are no excused absences.** In accordance with the attendance policy of SRJC, students are expected to attend all sessions of the course in which they are enrolled. Any student with excessive absences may be dropped from the class. A student may be dropped from any class when that student's absences exceed ten percent (10%) of the total hours of class time.

2. Tests - There will be two essay tests given during the semester. Check your course schedule for test dates.

3. Reading/Miscellaneous Writing Assignments - There will be a reading assignment for each class session. You are expected to have read the assignment before coming to class so that you are prepared to enter into class discussions and get the most out of class activities. Many of these in-class activities will be based on the reading and will require some writing. From time to time, I may also assign written work to be completed on your own. You will be graded/given credit for these miscellaneous assignments and in-class participation.

4. Community Agency Reports: For this assignment, students will investigate a local community agency serving children and families. This may be done alone or as a group project and will require a presentation to the class, a written report and a visual aid (poster, power point, website, or video). A format will be provided for the written report and for the presentation. The requirements for this assignment, including the formation of groups and assignment of agencies will be discussed in class.
