# \*COURSE OUTLINE OF RECORD: KAQUA 1.2

\*COURSE DESCRIPTION: Learning skills used in swimming, floating, gliding, rhythmic breathing, kicking, learning the front crawl stroke, elementary backstroke, breaststroke, back crawl, treading water, side stroke, and water safety skills. Learning the names of each stroke and each kick and the components of each stroke.

PREREQUISITES: Ability to swim Beginning level.

### \*COURSE CONTENT: Student Learning Outcomes:

- 1. Identify and demonstrate beginning/intermediate level swimming techniques, including rhythmic breathing, front crawl, elementary backstroke, back crawl, and breaststroke.
- 2. Demonstrate an understanding of proper swimming workout composition.
- 3. Identify and apply the different strokes, names of kicks, and safety skills.
- 4. Introduction to Butterfly stroke.
- 5. Learning to Dive.
- 6. Demonstrate proper body positions for each stroke.

### Objectives:

1. Improve physical fitness through progressive resistance training and aerobic swim exercise.

- 2. Develop a relationship with water for personal safety, enjoyment, and exercise.
- 3. Demonstrate proper body mechanics/posture and body core stabilization.
- 4. Demonstrate water safety skills and be familiar with rescue equipment.

### Topic and Scope

- 1. Stroke Mechanics and Breathing Mechanics
- A. Front Crawl
- B. Back Crawl
- C. Elementary Backstroke
- D. Breaststroke

#### \*ASSIGNMENTS AND GRADING:

Representative assignments may include:

- 1. Written assignment about swimming experience.
- 2. Short quizzes to reinforce the concepts listed above.
- 3. Midterm and Final exams.
- 4. Skill demonstration of strokes.

\*EVALUATION AND GRADING POLICY: Attendance 40-55% of your grade, written assignment is 5-10 % and the exam is 20% with skill demonstration 20 %.
