4. GENERAL GUIDELINES

A. GRADING POLICY

Homework will be graded as complete or incomplete.

All other work will be graded as follows:

90%-100% = A 80% to 89% = B 70%-79% = C 65%-69% = D <65% = F

Late work:

- i. Homework may be turned in up to one week late for half credit
- ii. Assignments other than homework that are turned in late will be downgraded by 10% the first week late and 20% the second week. Late assignments will not be accepted after 2 weeks. Students who turn in late assignments may, upon request, complete additional assignments to make up for the downgraded percentage. These assignments will be equal to or greater in scope than the original late assignment.
- iii. Tests and quizzes must be taken at the designated times. Quizzes cannot be made up. In circumstances where a student is unavoidably absent for a test, a makeup test or assignment may be given at the instructor's prerogative.
