Course Description: The study of public speaking. Improves the student's ability to prepare and deliver a public speech. Improves the student's ability to critically evaluate various forms of communication.

Student Learning Outcomes:

Upon completion of this course, students will be able to:

1. Effectively prepare and present public speeches to a live audience using contemporary technology when appropriate;
2. Demonstrate active listening skills;
3. Critically evaluate various forms of communication.

Course Requirements

Chapter Quizzes: short multiple-choice quizzes in Canvas on assigned reading; due before the class for which the reading is assigned. Late quizzes will only receive half credit.

Written Exam: a cumulative multiple-choice exam during the final exam period assigned by the college.

Speeches: five speeches, of varying lengths and types. Three written sentence outlines are due in advance using TurnItIn.com; those speeches are delivered extemporaneously from key-word outlines. One speech requires the use of presentation technology. One speech is prepared and delivered in a single class (impromptu).

Self Observations: all speeches are video recorded; students critique their own performance on each video in a short essay.

In-Class Exercises and Participation: Students participate in feedback sessions for all speeches performed in class, critique video-recorded speeches shown in class, and engage in other exercises related to course content.

Optional Credit: Students may earn up to 50 points by attending speech events on campus or in the community and evaluating them by course standards. Video-recorded options are available.

Course Policies

Attendance:

- This is a participation-oriented class. You are expected to attend all class meetings, and to contact me if something prevents you from attending.
- If you miss more than four classes, then in accordance with district policy, I may drop you.
- In-class activities earn points. Most in-class activities cannot be made up.
- If you know in advance that you will be absent, or if illness or another personal situation causes you to be absent for more than one class, you need to contact me. I will try to arrange for you to complete the work, but it may not be possible.
- **You should never be absent when you are scheduled to give a speech, as there may not be time for you to make it up.** If you cannot avoid being absent on a day when you are scheduled to speak, you will only be able to give your speech if there is extra time, and if you are present and prepared when the opportunity arrives. Speeches delivered late may be assessed a penalty and there is no guarantee that you will have the opportunity to give a late speech.
- Tardy arrival or early departure count as partial absences.

Communication:

- I will send communication outside of class time using the college's Portal email system and/or the Canvas messaging system.
- It is your responsibility to be sure that the college has an up-to-date email address on file, so that you will receive these messages.

- If you use email, be sure that your name and section number are clearly visible in the address and/or subject line of your message, and use the subject line to indicate what your message is in regard to. Follow up with me if you do not receive a reply to a message you sent, and save copies of all sent messages until you are sure they are received. In the event of an error, you can provide a copy with the correct date and time you originally sent the message.
- Please do not email questions that you could have answered yourself with due diligence. If the answer to your question is readily available in the syllabus or in Canvas, I will refer you there.

Class Conduct:

Emergency Evacuation Plan
