Training in the use of QuickBooks software for personal and business applications. Topics include information gathering, setting up accounts, payroll setup, working with lists, recording sales and purchases, inventory, tracking sales tax, banking procedures and financial reports.

7. Set up basic payroll
8. Produce financial reports

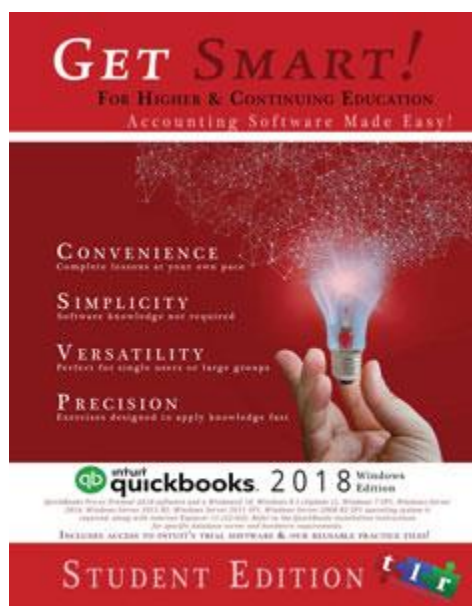
Students will be able to:

Course Outline of Record

Textbook and Materials

The required textbook is Get Smart with QuickBooks 2018 for Microsoft Windows. The text comes with a 160-day trial version of QuickBooks 18. Please be aware that you can NOT use earlier versions of the QB software with more recent editions of the textbook because you will not be able to open the training files for each lesson.



Hardware and Software

You will need a PC to complete this class. Yes, there is a MAC version of QuickBooks, but the student files that come with the textbook are Windows PC only and cannot be used on a MAC.

Please note: You do not have to change your system date to do the computer steps. Just make sure that the dates you enter for the documents are the same dates that are displayed in the lesson; and for the practice exercises, you can use November 1, 2018.

The student files can be downloaded from the [publisher site](#). Follow the installation and use directions found in the “Before You Get Started” portion of the text (the pages with Roman numerals). Your text will give you the access code for **the free trial download of QB**.

We will use QuickBooks 2018 (Pro, Premiere, or Accountants edition). You could use the 160-day trial version that works very well, or usually Costco has a good price on QB software as well. Or you could obtain a copy by calling 888-246-8848 (or order online at 222.intuit.com or quickbooks.com).
