#### Course Description:

This course will provide an overview of the use of anesthesia for the small animal veterinary workplace.

# Students will become familiar with anesthetic medications, **anesthetic instrumentation** and equipment, patient assessment, **anesthetic induction**, and **anesthetic monitoring** and response for the small animal patient.

This course is part of the SRJC program that fulfills the academic requirements to be eligible to sit for the California Registered Veterinary Technician board exam via the Alternate Route.

#### Course Objectives:

Upon completion of this course, the student should be able to:

- 1. Discuss the indications and risk factors for anesthetic procedures.
- 2. Evaluate anesthesia logs and anesthetic medical records.
- 3. Describe the stages of anesthetic depth and equipment to monitor anesthetized patients.
- 4. Identify anesthetic equipment including parts of inhalant anesthetic machines.
- 5. Describe common anesthetic emergencies and appropriate response to correct anesthesia related complications.
- 6. Evaluate protocols for anesthetic procedures.
- 7. Identify common veterinary medications and mechanism of action of anesthetic medications.
- 8. Discuss appropriate use and selection of anesthetic medications.
- 9. Perform drug dosage calculations for oral and parenteral medications.

Anesthesia Protocol = 10%

- The goal of this assignment is to create a functional reference that is useful in the workplace
  - You will be select the full drug protocol to be used for a patient
    - Can be any species of patient of your choosing
    - Must include pre-op, induction, maintenance and post-op meds
- Your drug selections are due 9/21 (2% of total grade)
- Your drug selections in the form of a dose calculating spread sheet (3% of total grade) is due on 10/12
- Reference with special considerations for each drug due 11/2 (5% of total grade)
  - Can be organized by drug or by organ system
  - Include all relevant information such as side effects, contra-indications, drug interactions, impact on monitoring, etc
  - Can be either paragraph or bullet point format
  - Expected length 2-3 pages

Special Anesthesia Topic = 15%

- You will be assigned 1 to 2 partners and a chapter from the text on 10/12 to summarize in the following assignments:
- A reference sheet for use in a clinical setting
  - Expected length 1-2 pages
