**Course Description:** This course reviews prevention and education techniques and strategies used in the field of addiction studies. Students will analyze the ways in which education can and does assist in the prevention of addiction and relapse. Students will explore the application of harm reduction strategies to other public health issues. Besides lecture, texts and articles, the course has interactive elements for students, such as field trips along with videos and guest speakers.

#### **Instructors Personal Teaching philosophy**

I believe in the process of transformational education and personal growth. I, along with students, participate in an ongoing exchange of ideas from both the academic perspective and the lived experience as part of higher learning education. I exchange knowledge in an active learning community and participate in mutual understandings of diverse styles of learning and engagement. I attempt to create a space to empower students and assist in co-creating new ideas and information that is based on lived experiences.

The courses that I teach will have immediate empathetic connections to students, clear academic statements, clear grading expectations and accessibility to me as an instructor. I will make sincere attempts to not create binaries that hinder or exclude students of any racial, ethnic, gender spectrum backgrounds.

## Learning Outcomes for Course.

1. Describe warning signs, symptoms, and causes of substance use disorders.

2. Analyze the ways in which education can and does assist in the prevention of communicable and infectious diseases among drug users and the application of harm reduction strategies to other public health issues.

3. Describe the basic principles of personal and public health, and substance abuse prevention, treatment, and recovery.

4. Identify and explain the common characteristics of children of substance abusers.

# **Objectives:**

Students will be able to:

- 1. Identify and interpret the role of the addiction professional to address prevention as well as treatment.
- 2. Predict factors that increase the likelihood for an individual, community, or group to be at-risk for, or resilient to, psychoactive substance-use disorders.

3. Identify issues of cultural identity, ethnic background, age, and gender, in prevention, treatment, and recovery.

- 4. Analyze warning signs, symptoms, and the course of substance abuse disorders.
- 5. Describe how substance abuse disorders affect families and concerned others.

### **Assignments:**

- Should be formatted with a 12-point font Times Roman, name, date, course title, instructor name, on the top left of document.
- Read approximately 20-30 pages each week (books, articles other documents)
- Short quiz at end of September, October, November total of (3)
- Interview: 1 oral (power point 1-2 slides only) **or** a written report 2 single space pages in which students visit and interview a local government official or AOD agency or community leaders of your choice, "asking what their office is doing in regard to substance use prevention in Sonoma County?". The paper should also incorporate the students' personal reflections about the experience. Due October 3, 2022.

**(Midterm)** One 4-page double spaced paper evaluation and or critique of the Sonoma County Strategic Alcohol and Other (AOD) Drugs Prevention plan.

(Final Exam) 5-page paper double spaced, topics should be focused on the following: (prevention issues in Black, Indigenous Peoples of color, socio-economic, impact of AOD on children, systemic causes of AOD).

#### Grading:

Reading & writing assignments = 15% Class participation/ discussion = 10% Quizzes =15% Mid-Term essay = 25% Final Paper = 35%
