 - issues, synthesizing information, health promotion, formulation of a comprehensive dental hygiene care plan, and the evaluation of patient treatment in the provision of comprehensive dental hygiene care (competent level).
- 2. Apply appropriate medical and dental precautions in patient treatment; determine proper precautionary procedures including consultation and referral) and apply those procedures during treatment (competent level).

Objectives:

Students will be able to:

- 1. Establish dental hygiene treatment/care plans through the use of advanced case studies.
- 2. Perform appropriate advanced preventive procedures on a variety of patients.
- 3. Demonstrate advanced instrumentation and techniques utilizing hand-powered and ultrasonic scaling devices.
- 4. Perform advanced techniques used to detect and remove plaque, calculus, and altered cementum from unattached tooth surfaces using advanced instrumentation.
- 5. Perform advanced dental hygiene skills: scaling and root planning, administration of local anesthesia, nitrous-oxide, the placement of occlusal sealants, fluoride therapy, and interpret images on a variety of patient classification.
- 6. Perform dental hygiene services for patients at off site rotations.
- 7. Demonstrate the adjunctive procedure soft tissue curettage.
- 8. Demonstrate a continued high level of professional and ethical conduct with patients, students, faculty and staff.
- 9. Demonstrate proficiency in the management of advanced patient care.
- 10. Demonstrate the ability to perform advanced patient care.
