Course Description

This course is designed to provide fitness training instruction and experience using proper form and technique based on principles of biomechanics and personal fitness level. This course offers flexibility to complete the participation requirement during any open gym hours at the assigned campus. Fitness assessments will be completed as part of the course.

Participation

This is a self-paced course where students have the flexibility to complete their required participation hours during any open hours of the fitness center throughout the term. For the 1.5-unit course, 52.5 hours are required. Students will log in and out when using the fitness center to document their hours. In the [Gradebook](#), students will see a regularly updated score out of 52.5 points (1 point = 1 hour completed) for the 1.5-unit course.

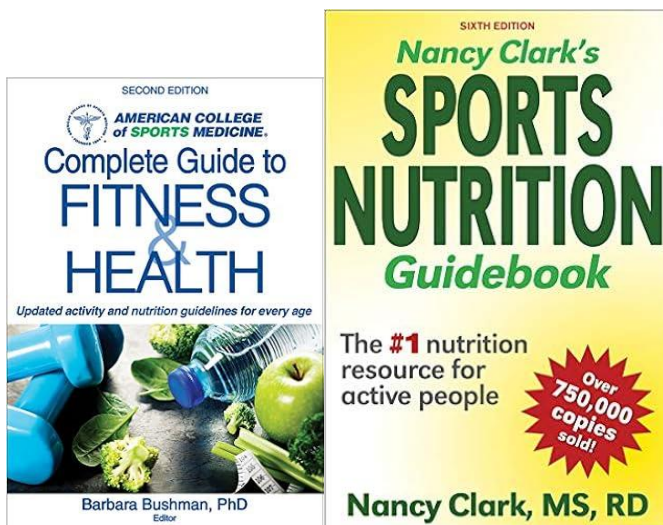
