## **COURSE CONTENT**

### **Outcomes and Objectives:**

1. Synthesize and evaluate the professional standards used in human services agencies.
2. Analyze and evaluate client/patient and counselor/client responsibilities.
3. Comprehend and evaluate the common employment problems/issues associated with chemical dependency.
4. Synthesize and analyze professional liability as it relates to Federal and State regulations.
5. Research and analyze the effectiveness of current prevention and educational strategies in the criminal justice system, alcohol and drug programs, and higher education.
6. Comprehend and evaluate the current legal issues regarding the use of alcohol and drugs associated with automobile accidents, social events, restaurants, liquor stores, bars and other life situations.

### **Topics and Scope:**

Legal and ethical issues in the delivery of human services.  
Ethical issues in the client/patient relationship.  
Ethical issues in the counselor/client relationship.  
New and current laws as they relate to counseling.  
Professional liability and confidentiality.  
Physical and emotional abuse of client and client families.

### **Assignment:**

Required reading assignment:
